

## **Little Mix - Timeline Memories - Submission Disclaimer & Release**

1. By submitting a memory or comment (your "Message") in celebration of 10 years of Little Mix (the "Artist), your Message may potentially be published on the Artist's '10 Years Between Us' timeline website (the "Timeline") and/or shared with and/or used by Sony Music Entertainment UK Limited ("SME") (and/or its licensees, affiliates or assigns) on the Artist's social media sites including but not limited to Facebook, Twitter, Instagram, YouTube and the Artist's official websites (the "Websites").
2. You acknowledge and agree that any Message submitted by you must be original and owned by you and not infringing the work and/or rights of any other person and/or entity, and that any Message submitted by you must not contain personally identifiable references to anyone other than you or the Artist, and must not contain any profanity or words in poor taste, or any third party IP (such as brand names) or personally identifiable information (such as addresses, telephone numbers, school names or your hometown).
3. By submitting a Message you warrant and represent that: a) you are the owner of the Message; and b) your Message does not and shall not contain a) any references to any person other than you, or any third party IP, or any personally identifiable information; and c) any material that: (i) impersonates any person or entity, or falsely states or otherwise misrepresents your affiliation with a person or entity, without such person or entity's prior written consent; (ii) is false, deceptive, misleading, obscene, pornographic, violent, unlawful, blasphemous, defamatory, libellous, threatening, racially or ethnically offensive; (iii) encourages conduct that could be considered a criminal offense, could give rise to criminal or civil liability, or could violate any law, or that could otherwise be considered inappropriate (in SME's reasonable opinion); (iv) constitute a virus, spyware, or other computer code, file or program that is harmful or invasive or may, or is intended to damage or hijack the operation of, or to monitor the use of the Websites, or any hardware, software, or equipment; (v) constitutes any advertising, promotional material, or other form of solicitation; or (vi) constitutes any non-public information about a company.
4. You agree to provide your full name on the submission form when submitting your Message in order that you may legally accept the terms hereunder. By submitting your Message, your name and any other personally identifiable information about you as part of your participation in this opportunity, you understand that any such personal data provided by you shall be processed by SME in connection with potentially using such Message, which may include your name and/or other personal information provided by you, for promotion of the Artist and/or the Timeline on the Websites. SME's lawful basis for this processing is to perform the contract set out in these terms, which cover the publication of the Timeline and promotion of the Artist and the Timeline. 5. You acknowledge that each Message provided by you to SME may be protected by copyrights, trademarks, service marks, patents or other intellectual property ("IP") rights and laws. You must not upload, display, send, transmit or otherwise make available any Message in which you do not have all appropriate rights to do so. Unauthorised copying, distribution, modification, display, public performance or other unauthorised use of copyrighted works by you may constitute an infringement of the copyright holders' rights and may result in civil litigation and criminal prosecution. You are solely responsible for the content of any material posted online by you, and any consequences of the further publication of such by SME and/or its licensees, affiliates or assigns. SME and its licensees, affiliates and assigns, shall have no liability whatsoever and howsoever arising for your Message or your material submitted. You hereby hold SME (and its licensees, affiliates and assigns) harmless from and against any third party claim arising from your Message and any material posted by you. You waive any right to privacy. You waive any right including any "moral right" to inspect or approve uses of your Message and/or your name and/or social media handle provided, or to be compensated for any such uses.

By submitting a Message, you hereby grant to SME (and its licensees, affiliates and assigns) a non-exclusive worldwide, royalty free, perpetual and irrevocable licence without further payment to use, edit, copy, transmit, display, exploit, manipulate, distribute, reproduce, make, sell or offer to sell; exercise all copyright, trademark, publicity and other proprietary rights (and to sub-licence such rights) to any such Message submitted by you, your likeness and any information you provided or any part thereof (including without limitation your name and/or social media handle), in any and all media (by any and all means now known or developed in the future), including without limitation, commercial audio or video products packaging and all forms of advertising and merchandise. You also grant an exclusive worldwide royalty-free licence without further payment to SME and other users to use, download and reproduce such content to the extent it may be reviewed and subsequently published on the Websites.

For the avoidance of doubt you understand that on a non-exclusive basis any Message submitted by you, your likeness, your social media handles and any information you provide may be used on a royalty-free basis without payment, worldwide and in perpetuity in services and products of the Artist including without limitation videos, publicity, advertising, websites, social media profiles and/or on forthcoming releases of an album or single, which may include packaging.
8. SME may at its sole discretion opt not to use, without notice or reason, any Message that SME believes is inappropriate or in breach of these rules or if it simply does not wish to use them. If SME (at its sole discretion) believes a Message

submitted by you breaches the terms herein, SME shall be entitled not use such Message or to remove such Message from the Timeline and Websites and/or to request that you take down your Message (if applicable) and you hereby agree to immediately so remove the Message upon such request.

So far as is permitted by law, SME assumes no responsibility for damages, losses, expenses or injuries that result from your Message upload, provided that nothing shall exclude or limit SME's and its associated companies' and agents' liability for death or personal injury caused by its negligence or fraud.
